Trade Practices

Overview

Before joining Francis Burt Chambers as a barrister, Michael was a solicitor and senior associate at Clayton Utz Lawyers in Perth (2000-2011). His practice at Clayton Utz involved commercial and civil litigation, with particular emphasis on large scale construction and engineering disputes.

Experience

Michael practises primarily in commercial litigation. He has represented many leading Australian and international companies as well as statutory corporations. He has extensive experience in typical construction claims (e.g. claims for extensions of time, variations, delay damages, defective works, provisional sums and latent conditions) as well as contractual, statutory and trade practices matters. Some recent examples of matters in which Michael has advised and represented clients are:

- an international arbitration under the UNCITRAL Arbitration Rules concerning the
 construction and refurbishment of a gold processing facility in Africa under an
 EPCM contract (acting for the principal). The matter involved breaches of
 contract and allegations of misleading or deceptive conduct under the Trade
 Practices Act.
- WA Supreme Court proceedings concerning the construction of commercial premises under a cost-plus contract (acting for the contractor). The matter involved breach of contract, rectification of defects, negligence and misleading or deceptive conduct.
- State Administrative Tribunal proceedings concerning the construction of mining plant in the Pilbara (acting for the principal). The matter involved an appeal under the Construction Contracts Act 2004.
- a domestic arbitration concerning the construction of commercial premises under General Conditions of Contract AS 2124 (acting for the contractor). The matter involved design defects and claims for extensions of time, delay damages and variations.
- WA Supreme Court proceedings defending allegations of misleading or deceptive conduct under the Trade Practices Act in relation to General Conditions of Contract AS 2124 (acting for the contractor).
- Victorian Supreme Court proceedings concerning the design and construction of 3

mineral processing plants in Victoria under an EPC contract (acting for the principal). The matter involved claims relating to provisional sums, variations, breach of warranties, latent conditions and sub-contractor claims as well as claims of misleading or deceptive conduct.

- a domestic arbitration concerning the processing of mineral sands under a mining services agreement (acting for the principal). The matter involved breaches of contract and an appeal to the WA Supreme Court.
- a domestic arbitration concerning the construction of an oil refinery in Papua New Guinea (acting for the contractor). The matter involved breaches of contract and design defects.
- WA Supreme Court proceedings concerning the construction of a townhouse development under an ABIC 2003 Major Works Contract (acting for the principal).
 The matter involved breaches of contract, claims for extensions of time, variations, delay damages and quantum meruit.
- WA Supreme Court proceedings concerning the construction of a bulk liquids jetty under a design and construct contract (AS 4902) (acting for the principal). The matter involved claims for breach of contract, extensions of time, delay damages and misleading or deceptive conduct.
- advising port authorities and other statutory corporations in relation to corporate governance issues and directors' duties.
- advising principals in relation to public liability insurance issues.
- advising a statutory corporation in relation to directors' and officers' insurance.
- acting for contractors in relation to professional indemnity insurance issues.
