WA Bar's office premises

For the past 12 months, The WA Bar has been located in its new premises at Level 16, Francis Burt Chambers. I would particularly like to acknowledge the efforts of my predecessor, Stephen Davies SC, who was responsible for the initiative and all aspects of the renovations and fitout. The WA Bar's premises provide it with a physical presence it has not previously had.

Bar Readers' Course

This year's Bar Readers' Course (BRC) was conducted over 8 weeks during late-April, May and June, with 45 new members completing one or more of the modules of the BRC.

The number of participants was higher than usual due to the cancellation of the 2020 BRC due to COVD-19.

A function to mark the closing of the BRC, award certificates and present prizes to the best performed readers was held on 25 August. Congratulations once again to Darren Pratt who was awarded the Chief Justice's prize for the best performed reader in the Ethics & Practice, Evidence, and Jurisdiction & Procedure modules, and to Stefan Tomasich who was awarded the prize for the best performed reader in the Essential Trial Advocacy Course.

Once again, many members of the Bench and senior members of the Bar willingly contributed their time and energy as Presenters and/or Course Coordinators. Their support ensures the ongoing success of the BRC and is greatly appreciated by both The WA Bar and participants.

Essential Trial Advocacy Course

The Essential Trial Advocacy Course (ETAC) was held between 18-22 January 2021 at the Supreme Court of Western Australia for Perth based participants. The WA Bar is very grateful to the Chief Justice of the Supreme Court who, once again, made that Court's facilities available for the Course. The facilities are excellent, and are a significant factor in ensuring the success of ETAC.

There were 17 participants from WA.

There were 11 coaches, comprising the Honourable Justice Banks-Smith, Matthew Howard SC, Martin Cuerden SC, Paul Yovich SC, Kim Lendich SC, Geoff Bourhill SC, Terry Palmer SC, Anthony Crocker, Bill Keane, Racheal Young and Julia Moody as the Voice & Performance Coach.

A pool of 23 volunteers (articled clerks and law students) played the role of volunteers and/or acted as camera operators. Their contribution is important and an essential element of a successful course.

The Honourable Justices Colvin, Mazza, Martin, Corboy and Archer attended on the final day to act as judges at the mock trials.

The Course culminated in the final dinner on the Friday night which was addressed after dinner by the Honourable Justice Colvin.

The success of the course is due to the collective efforts of all involved in ETAC.

A second ETAC was scheduled to take place in Perth between 5-9 July 2021 for Perth and Interstate participants and coaches, however the ETAC was postponed due to COVID lock-down/restrictions.

Arrangements are currently underway to conduct an ETAC in Perth involving Perth based participants and coaches between 17-21 January 2022.

2021 Spring CPD

Bar Council originally intended a different format for this year's Spring CPD Seminar Series, with an emphasis upon fostering collegiality at the Bar. Options included a two-day conference at Rottnest Island. However, for various reasons, principally the continuing uncertainty caused by the COVID-19 pandemic, it was resolved to continue with the current model at this stage, with a view to again considering alternative formats in 2022.

Pro Bono

Over the past 12 months, The WA Bar received 10 requests from members of the public which were referred to Law Access and/or other organisations for assessment/further assistance.

In addition, The WA Bar received 11 requests which were assessed as meeting the criteria for pro bono assistance. Of the 11 requests, 10 were circulated to members, and assistance was provided in 9 matters, and in most matters multiple offers of assistance were received from members.

The task of assessing and coordinating pro bono requests has been shared and undertaken by Elspeth Hensler and Fraser Robertson since June 2017, and prior to that for many years by Elspeth Hensler. Their outstanding efforts, for which we are truly grateful, ensure the prompt and efficient processing of requests.

After many years in the role, Elspeth has recently stood down from it. I would like to extend the thanks of The WA Bar for her years of service in this role, assisting to provide access to justice for many less fortunate members of our community.

While most requests for pro bono assistance received by The WA Bar from individual members of the public are redirected to Law Access for assessment, The WA Bar continues to accept referrals/requests from the Courts, community legal centres, from members of the public seeking family law assistance (in which case, requests are referred to FLAPA), and from members of the public who have approached the WA Bar at the request of their pro bono solicitor.

Staff

The WA Bar has two permanent employees: Debbie Cole (Executive Officer) and Karen Knox (Administrative Assistant). Both Debbie and Karen are integral to the efficient and effective operation of The WA Bar.

Debbie's and Karen's workload has steadily increased over the years, as The WA Bar has taken on more and more responsibilities. Early this year, I formed the view that The WA Bar should consider employing another person to provide administrative assistance for both Debbie and Karen. This, and possible solutions, were matters that I discussed with Debbie and Karen earlier this year. The possibility of employing additional staff was ultimately reflected in the 40% increase in The WA Bar's budget for Salary Costs which Bar Council approved for the 2021-2022 financial year.

Unfortunately, for personal reasons, Debbie Cole has been required to take leave since 23 March 2021. Debbie's absence has been keenly felt. With effect from 3 May 2021, Bar Council engaged Samantha Harper on a 6 month contract as Acting Executive Officer. More recently, Bar Council resolved to extend Debbie Cole's leave for a further 6 months from 28 October 2021, and to re-engage Samantha Harper for a further 6 month contract from 5 November 2021 on terms which are yet to be finalised.

The role of Executive Officer of The WA Bar is a bespoke and difficult one, and Samantha has shown herself to be enthusiastic and more than capable of learning the role and taking on the challenges. On behalf of Bar Council, I wish to express my thanks and appreciation to Samantha Harper for her very considerable assistance this year.

However, I would particularly like to acknowledge the inestimable value to The WA Bar of Karen Knox. The fact is that without Karen, the WA Bar would simply not have been able to operate following Debbie's absence. Time and time again, Karen went well beyond what could reasonably have been expected of her, both in terms of the hours she has worked and the tasks she has taken on, in order to ensure that The WA Bar continues to function effectively and successfully. The tasks which Karen has taken on, as demanding as they are, have been made even more demanding by the ongoing effects of the COVID-19 pandemic.

Karen has done this unassumingly, without expectation of recognition or reward, because she genuinely cares about the success of The WA Bar and its members.

Accordingly, I wish to express my sincere personal gratitude, and the gratitude of Bar Council, to Karen for everything she has done for The WA Bar, particularly over the past 12 months.
